Types of information we may collect from you

How we may use the information we collect

We use the information in the following ways:

Information you supply to us will be used to:

Information we automatically collect about you will be used to:

- Security and debugging as part of our efforts to keep our site safe and secure.

Disclosure of your information

Any information you provide to us will either be emailed directly to us or may be stored on a secure server located in the Isle of Man. We use a trusted third party website and hosting provider (Squarespace) to facilitate the running and management of this website. Squarespace meet high data protection and security standards and are bound by contract to keep any information they process on our behalf confidential. Any data that may be collected through this website that Squarespace process, is kept secure and only processed in the manner we instruct them to. Squarespace cannot access, provide, rectify or delete any data that they store on our behalf without permission.

We do not rent, sell or share personal information about you with other people or non-affiliated companies.

We will use all reasonable efforts to ensure that your personal data is not disclosed to regional/national institutions and authorities, unless required by law or other regulations.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your

information, we will use strict procedures and security features to try to prevent unauthorised access.
